5. 消防措施(Fire Fighting Measures)

7. 操作和贮存(Handling and Storage)

Handling:

1. 电池被设计为可充电的, 然而不正确的充电方式可能会导致电池着火。当给电池充电时, 要使用专用的充电器并按照指定的充电条件进行。
