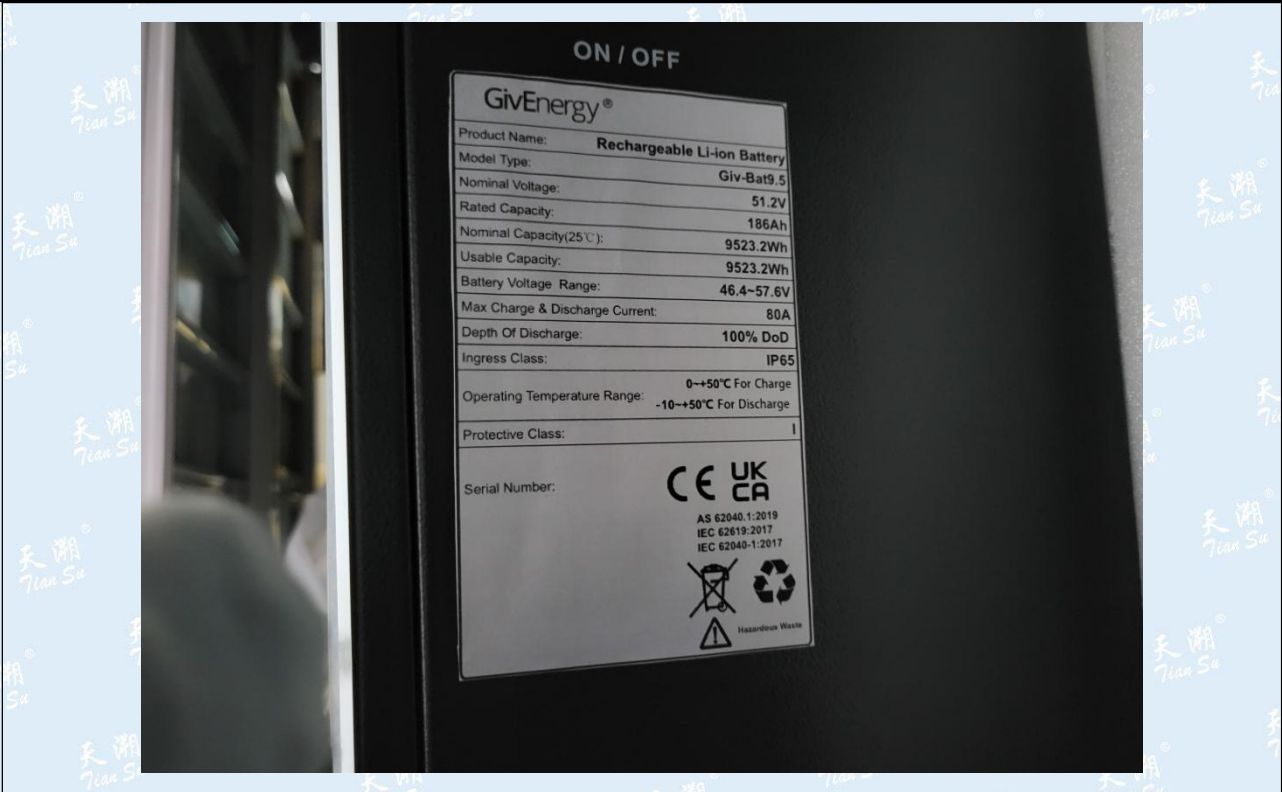

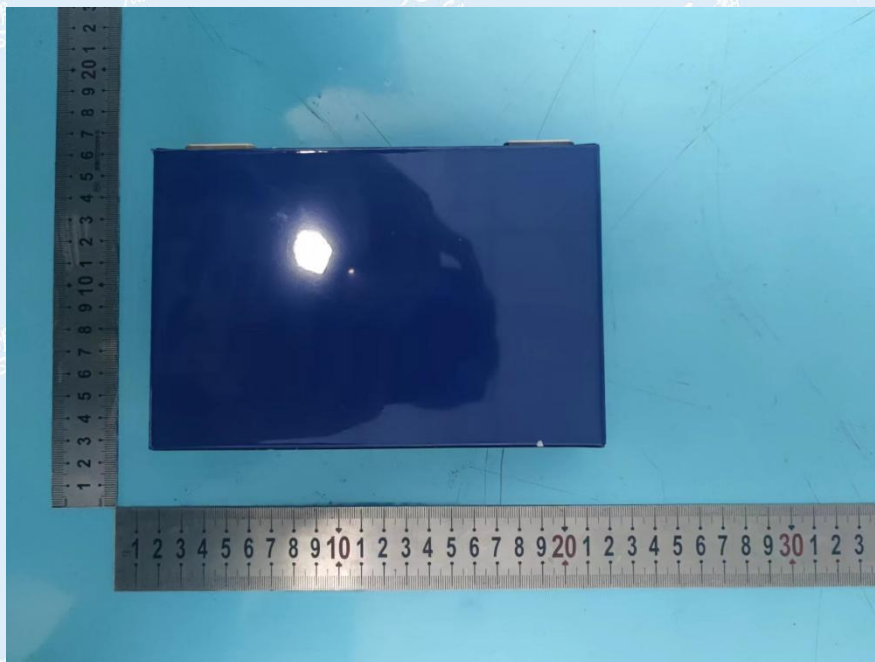
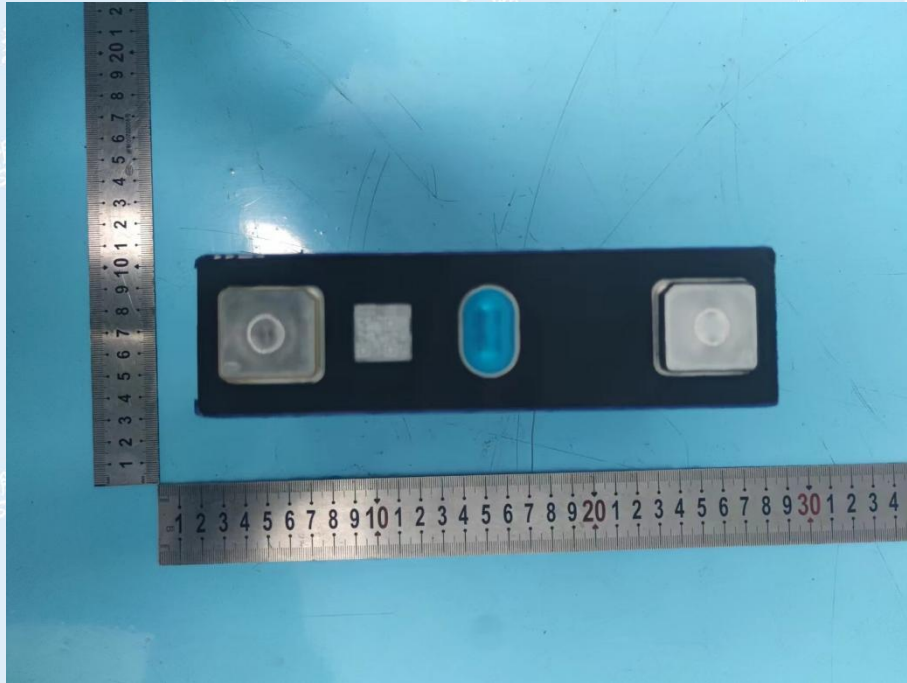

The crushing is to be gradual with a speed of approximately 1.5 cm/s at the first point of contact.
